Office of Rural Health 101

- All 50 states have a State Office of Rural Health (SORH).
- Every state receives a portion of their funding from the Federal Office of Rural Health Policy through the SORH Grant program, which began in 1991.
- Primary Objectives with funding:
 - Coordinate rural healthcare activities in states in order to avoid duplication
 - $\circ~$ Provide technical assistance to public and non-profit private entities

South Carolina Office of Rural Health is the sole organization in South Carolina that is federally designated to address the health needs in rural communities.




SCORH works with local, state and national partners to:

Single Food Lion and farmer's market to accommodate 18,000 residents in Saluda County

Nearly 1.4 million South Carolina residents call a rural community their home.


2017 Rural Health Action Plan





Community Food Alliance

The South Carolina Community Food Alliance is a collaborative effort between SCORH, SCACED, SC Department of Commerce, and SCCLF. The partnership is a result of Growing Local SC, a 2021 USDA-awarded Regional Food System Partnership (RFSP) project working to formalize a cross-sector local food system network that cultivates a thriving, equitable, inclusive, and resilient food economy providing access to healthy food for all. Guided by Growing Local SC's leadership, the partners formed SC Community Food Alliance, which aligns with the RFSP project goals to address food system gaps and facilitate food access solutions in rural communities using a multi-prong approach.



Pathways to Food Access

- 1. Create a Community Food Access Toolkit: Self Assessment and Resource Guide to evaluate the options available, resources they have and may need, and a process for engaging with community members.
- 2. SCORH's Community Health Transformation team would offer technical assistance to selected Rural community leaders to activate the toolkit and develop a plan for action towards business development.
 - Utilize the Community Food Access Toolkit: Self Assessment and Resource Guide in the community; Discuss the Assessment results; Review Results Based Accountability Action Plan; and, Develop plan to survey community members.
 - Review rural models of food retail with community leaders informed by the results of the Community Food Access Toolkit using examples from the Rural Grocery Institute.
 - At this point, leaders would identify and evaluate potential spaces for revitalization with local officials.
- 3. Selected entrepreneurs/small business leaders would transition into the Community Loan Fund's entrepreneurship program, where they would complete a pitch deck and business plan with an opportunity to receive seed money.
- 4. As needed, work with the Small Business Development Center to create business plans and/or operating structure and business entity procedures.
